### 2.1 Personal Information

We may collect personal information you voluntarily provide, including:

2. Email address
3. Phone number
4. Account login credentials
5. Billing and transaction details
6. Communications with support or form submissions

Automatically collected information may include:

1. IP address

3. App usage data, pages/screens viewed, session duration
4. Log files, diagnostic data, and crash reports
5. Cookies and similar tracking technologies

## **3. Legal Bases for Processing (GDPR / UK GDPR)**

We process personal data only where a lawful basis applies, including:

1. Contractual necessity – to provide Services
2. Consent – for marketing and non-essential cookies
3. Legal obligation – accounting, tax, regulatory compliance
4. Legitimate interests – fraud prevention, security, service improvement

## **4. How We Use Your Information**

We use personal data to:

1. Provide, operate, and maintain the Services
2. Process payments and manage transactions
3. Create and manage user accounts
4. Communicate updates and respond to inquiries
5. Improve content, features, and performance
6. Prevent fraud and ensure platform security
7. Comply with legal and regulatory obligations

AccademyX does not store full payment card details.

For mobile apps:

1. iOS payments via Apple In-App Purchases
2. Android payments via Google Play Billing

## 6. Cookies & Tracking Technologies

We use cookies to ensure functionality, analyze performance, and remember preferences.

Cookie categories include:

1. Strictly necessary cookies
2. Analytics cookies (consent-based where required)
3. Functional cookies
4. Marketing cookies (only with explicit consent)

Users may manage cookies through browser or device settings.

## 7. Data Sharing & Disclosure

We do not sell or rent personal data.

We may share data only:

1. With trusted service providers for service delivery
2. Where required by law or legal process
3. To protect rights, safety, or property
4. In business transfers or restructurings

## 8. International Data Transfers

Data may be transferred outside the EEA or UK.

Appropriate safeguards such as Standard Contractual Clauses are applied.

We retain personal data only as long as necessary for:
